MINUTES FOR MANAGERS' MEETING April 12, 2021

The Board of Managers, Buffalo-Red River Watershed District (BRRWD), held their regular meeting on Monday, April 12, 2021, at 7:00 PM in the Barnesville office. Due to the Coronavirus protocols for public meetings, the meeting was available online following Minnesota Statutes Annotated (M.S.A.) Section 13D.021. BRRWD Managers present were Peter V. Fjestad, Catherine L. Affield, Gerald L. Van Amburg, John E. Hanson, Mark L. Hanson, Troy E. Larson, and Paul G. Krabbenhoft. BRRWD staff in attendance were Kristine M. Altrichter, Administrator, Erik S. Jones, Engineer, and Bennett Uhler, Engineer, Houston Engineering, Inc. (HEI). Others attending in person: Nathan Strand, Barnesville River Watch; and landowners Jay Nord, Dan and Natalie Herzog, and Gerry Zimmerman. Attending online: BRRWD Attorney Tami Norgard, Vogel Law Firm, and others.

At 7:00 PM, President Fjestad called the meeting to order and informed the audience that the meeting was being recorded to aid in the preparation of minutes.

<u>Agenda.</u> Additions to the meeting agenda: Manager M. Hanson wanted a discussion regarding the online conferencing, and Jones suggested the addition of the damage statements for Clay County Ditch (C.D.) Nos. 12, 21, 55, 58, and 69. <u>Motion</u> by M. Hanson to approve the amended agenda. <u>Seconded</u> by Affield. <u>Approved</u> by unanimous roll call vote.

Secretary's Report. The Board reviewed draft minutes for the 3/22/21 regular meeting, the 3/22/21 Wilkin C.D. No. 13 hearing, the 4/7/21 Whiskey Creek Enhancement hearing, the 4/8/21 buffer strip hearing for Clay C.D. Nos. 2, 3, and 35, and the 6/27/17 Whiskey Creek Enhancement project informational meeting. Affield noted a minor correction to the 3/22/21 regular meeting minutes. Motion by Affield to approve the minutes, subject to correction. Seconded by Krabbenhoft. Approved by unanimous roll call vote.

Treasurer's Report. The Board reviewed the BRRWD's 4/12/21 financial report. Cash on hand is \$2,558,902.12. Income received since the 3/22/21 meeting totals \$150,840.10, and for the year, totals \$733,484.66. Year to date Accounts Receivables total \$14,200,263.10. **Motion** by J. Hanson to approve the Treasurer's Report. **Seconded** by Affield. **Approved** by unanimous roll call vote.

Citizens to be Heard:

Barnesville River Watch. The Board reviewed and discussed the River Watch proposed 2021-2022 budget totaling \$5,562.56. **Motion** by Van Amburg to approve the River Watch budget. **Seconded** by Krabbenhoft. **Approved** by unanimous roll call vote.

Nathan Strand, River Watch Advisor, discussed the Barnesville High School River Watch program and thanked the Board for their support.

Other Business brought before the Board included:

<u>FM Diversion Lawsuits.</u> Jones reported that he has been in contact with the Diversion staff to let them know the BRRWD is ready to move forward with the Memorandum of Understanding (MOU) documents for the Cities of Wolverton and Georgetown. The MOUs are in the draft stage and will be circulated to the

entities in the near future. The FM Diversion Settlement Agreement is still under review by the BRRWD Attorneys. When the legal review is completed, Fjestad and Affield are authorized to sign the document.

<u>Permit No. 21-009, Jay Nord.</u> Applicant proposes the installation of 157 acres of pattern tile in the SW¹/₄, Section 26, Wolverton Township, Wilkin County, outletting via lift station across Mike Aigner's property for approximately 500', eventually to Wolverton Creek. Nord submitted the signed downstream landowner notification form from Aigner. Jones recommended permit approval, subject to our standard tiling disclaimer.

Permit No. 21-016, Trygve Skolness. In response to Dan and Natalie Herzog's concerns about impacts to their downstream farmstead and BRRWD staff suggestion, Skolness agreed to relocate his original tile lift station from the northwest corner of the W½, Section 23, Moland Township, Clay County, to the southwest corner of the section to Clay C.D. No. 2 to which the property is assessed. With that outlet location change, Jones recommended permit approval, subject to our standard tiling disclaimer.

Permit No. 21-028, Edward Strom. This permit was approved at the 3/22/21 meeting to pattern tile 143 acres in the NE¼, Section 7, Hamden Township, Becker County, outletting south to Becker C.D. Nos. 6 and 15. Upon further review, Jones contacted Strom to discuss revising his plan to keep the tile off the Becker C.D. No. 6 right-of-way (R/W) on the west side of his field. The plan now allows for a 70' corridor along the ditch. Staff is working with landowners along the ditch to install buffer strips on the C.D. No. 6 R/W. Jones recommended approval of the revised permit, subject to our standard tiling disclaimer.

Permit No. 21-029, Todd Schauer. Applicant proposes to install 33 acres of tile in the W½SW¼, and the SW¼NW¼, Section 23, Skree Township, Clay County, outletting via gravity to a low area adjacent to Hay Creek. Jones recommended permit approval, subject to our standard tiling disclaimer.

Permit No. 21-030, John Jaehning. Applicant proposes to install a tile main in the NW¹/4, Section 10, Connelly Township, Wilkin County, in the bottom of an existing surface ditch with two upstream surface inlets, outletting via a lift station to a Whiskey Creek tributary running through the NE¹/4, Section 9, Connelly Township. The tile main installation is in preparation for a project to tile the entire quarter in the next two years. Jones recommended permit approval, subject to our standard tiling disclaimer.

Permit No. 21-031, Clay County Highway Department. Applicant proposes to replace two lines of 10' 11" x 7' 1" corrugated metal arch pipe (CMP-A) with one line of 14' x 9' box culvert/end sections with minor grading to match the current ditch grade. The new culverts' capacity and hydraulics match the existing structures. The work is on Clay C.D. No. 10 in the NE¼, Section 13, Kragnes Township. Jones recommended permit approval.

Permit No. 21-032, Clay County Highway Department. Applicant proposes to replace two lines of 10' 3" x 6' 9" CMP-A with two lines of 9' x 6' box culverts/end sections with minor grading. The new culverts' capacity and hydraulics match the existing structures. The work is on Clay C.D. No. 10 in the NW1/4, between Sections 15 and 22, Morken Township. Jones recommended permit approval.

Permit No. 21-033, Paul Dubbels. Applicant proposes to reinstall an approach with a culvert in the SE¹/₄, Section 6, Humboldt Township, Clay County. The landowner received a permit in 2006 (Permit No. 06-071) to remove the approach as it was no longer needed at that time. The new field entrance would be reinstalled near the previous field entrance location. Jones recommended permit approval with a 36" dia. CMP, subject to township approval to work within their road R/W.

<u>Permit No. 21-034, Larry Heng.</u> Applicant proposes 25 acres of pattern tile in the SE¹/₄, Section 30, Skree Township, Clay County, outletting to an existing tile project to Spring Creek. Jones recommended permit approval, subject to our standard tiling disclaimer.

Permit No. 21-036, Ron Conzemius. Applicant proposes to install 128 acres of pattern tile on the west side of Trunk Highway (T.H.) No. 9 in the NW¹/₄, Section 16, Manston Township, Wilkin County, outletting via a lift station in the northwest corner of his field into a ditch on the west side of Section 9, eventually to the South Branch of the Buffalo River. Jones recommended permit approval, subject to our standard tiling disclaimer.

<u>Permit No. 21-037, Troy Larson.</u> Applicant proposes to install a new field approach/18" dia. culvert in the SE¹/4, Section 10, Akron Township, Wilkin County. Jones recommended permit approval, subject to County approval to work within their road R/W.

Permit No. 21-038, Pheasants Forever (PF). Applicant proposes to restore five wetlands with ditch plugs, ditch fills, and sediment removal in parts of the N½, Section 5, Parke Township, Clay County. The Board discussed seepage concerns and reviewed elevations for Wetland No. 2. The Board consensus was that Wetland No. 2 could be restored; however, if it causes seepage to the south in the future, it would need to be removed. Jones recommended permit approval.

<u>Permit No. 21-039, PF.</u> Applicant proposes to restore three wetlands in parts of the NW¼ and the N½NE¼, Section 10, Manston Township, Wilkin County, associated with the South Branch of the Buffalo River Restoration project on the former Rogelstad property, which PF recently acquired. Jones recommended permit approval.

The Board discussed establishing a policy for how long a permit application should be kept active while awaiting documentation from the landowner. Jones checked with the Minnesota Board of Water and Soil Resources (BWSR) and Clay County Planning and Zoning regarding their policies.

<u>Motion</u> by J. Hanson to approve Permit Nos. 21-009, 21-016, 21-028 through 21-034, and 21-036 through 21-039, subject to the referenced disclaimers and conditions. <u>Seconded</u> by Krabbenhoft. <u>Approved</u> by unanimous roll call vote.

Whiskey Creek Enhancement. The Board reviewed responses that Jones and Bennett Uhler, Engineer, HEI, prepared to address landowner comments from the 4/7/21 hearing. One of the main concerns was about the watershed management district (wmd) fee rates. The proposed rates would range from about \$2.50/acre on the east wmd boundary to \$1.64/acre on the west side along the Creek. Jones explained that the criteria for setting the rates is determined by what the estimated change in sediment delivery and the change in runoff would be off a particular parcel based on soils, land use, and terrain data. He added that the Board does have some discretion in setting the wmd fee rates. After discussion, motion by Krabbenhoft to assess all the agricultural land at the same wmd rate. Seconded by J. Hanson. Approved by unanimous roll call vote. Jones noted that the wmd fee rates will be revised, in accordance with the Board decision, and the project Findings and Order will be prepared for the Board's approval at the upcoming 4/26/21 meeting.

<u>Ditch Buffer Findings and Order.</u> The Board reviewed the Findings and Order for the buffer installations on Clay C.D. Nos. 2, 3, and 35. <u>Motion</u> by Van Amburg to approve the Findings and Order for the referenced three ditch systems. <u>Seconded</u> by M. Hanson. <u>Approved</u> by unanimous roll call vote.

The Board reviewed the revised damage statements and Order for C.D. No. 39 that reflect the changes to Gerry Zimmerman's R/W in Section 31, Morken Township, to allow for the recently established Judicial section line (2015). **Motion** by Krabbenhoft to approve the revised damage statement and Order, as referenced. **Seconded** by J. Hanson. **Approved** by unanimous roll call vote.

Zimmerman asked about the design proposed to address slumping sites along C.D. No. 10 in Sections 15 and 17, Morken Township, on township roads. Jones explained the proposed repairs, incorporating a light-weight concrete product and granular fill.

The Board reviewed the damage statements for Clay C.D. Nos. 12, 21, 55, 58, and 69. <u>Motion</u> by Van Amburg to accept the damage statements. <u>Seconded</u> by Larson. <u>Approved</u> by unanimous roll call vote.

South Branch of the Buffalo River Restoration. The BRRWD received a BWSR Clean Water Funds (CWF) grant to be used in part for the development of Phase 2 of the South Branch project, the next stretch of the downstream channel west of T.H. No. 9. Because this part of the South Branch is Minnesota Department of Natural Resources (DNR) Public Waters, an environmental review, including an Environmental Assessment Worksheet (EAW), will be needed to obtain the DNR permit for the project. The EAW would cover about 20 miles of the river channel from the Clay County line upstream into Wilkin County to T.H. No. 9. **Motion** by J. Hanson to authorize HEI to prepare the EAW. **Seconded** by Affield. **Approved** by unanimous roll call vote.

MS4. At the 3/22/21 meeting, the Board approved the Municipal Separate Storm Sewer System (MS4) MOUs for Clay County and the Cities of Moorhead and Dilworth to address overlapping MS4 responsibilities with the other Local Government Units (LGUs). The MOUs were signed by the other entities and are ready for the BRRWD's signature. Motion by J. Hanson to authorize signature of the MOUs on behalf of the BRRWD. Seconded by Larson. Approved by unanimous roll call vote.

Red River Basin Commission (RRBC). The RRBC submitted a request for the BRRWD's 2021 funding contribution of \$25,000. The Board discussed the history of the BRRWD's annual contributions in support of the RRBC's activities. **Motion** by J. Hanson to approve the payment. **Seconded** by Affield. **Approved.**

HR Committee Staff Transition. Altrichter reported on her progress with the staff transition. She met with the HR Committee to review benefits, payroll, salary study, and the updated Handbook. She is working on finalizing the benefit package for the Board's approval. Altrichter met with Payroll Professionals and received a proposal from them to handle the staff payroll. Sarah Noah, Noah and Associates, completed a salary study for similar positions across the northwest region. The HR Committee is reviewing a draft Employee Handbook. Other items still under consideration include a staff vehicle, Public Employees Retirement Association (PERA) staff retirement accounts, and IT issues, including phone, website, and the Board Room AV system. RaeAnn Berg's computer will also need to be replaced.

<u>Bills.</u> The Board reviewed bills totaling \$577,014.66. **<u>Motion</u>** by Van Amburg to approve payment of the bills. **<u>Seconded</u>** by M. Hanson. **<u>Approved</u>** by unanimous roll call vote. See detailed bill list below.
