Project No. 31 – Deerhorn Creek Basin, Landowner Request. Greg Grommesh requested BRRWD reinstall a culvert that washed out along Deerhorn Creek in Section 22, Atherton Township, Wilkin County. Upon request, Schlauderaff reviewed and found a 30" cmp downstream from the crossing that is no longer useable. Schlauderaff reviewed easement document which stated maintenance could be done by the grantor (Watershed) but flood damage should be done by the grantee (landowner). Schlauderaff noted the crossing was likely undersized and a larger culvert would likely be needed. Uhler stated a hydraulic study would be needed and staff could work with Minnesota DNR to get a permit for work within a Minnesota Public Water. Motion by Stubstad to authorize staff to assist Grommesh with hydraulic study and Minnesota DNR permitting, as BRRWD has done with similar requests, but culvert cost and installation to be paid for by landowner.
